

Aims and Objectives

- To enable adults to remain at home in the last weeks of life, regardless of diagnosis, if this is their choice.
- To work closely with their key worker - usually a Community Nurse and plan the care required and review on a daily basis.
- To offer support to colleagues in the community.
- To meet the physical, emotional and spiritual needs of patients during the last weeks of life.
- To audit and develop the service in line with service users requirements, and local and government guidelines.
- To facilitate reduction in the numbers of unnecessary admissions to hospital/hospice/nursing home in the last few days of life.
- To allow discharge from hospital/hospice/nursing home in the last few days of life, enabling preferred choice of care/death.

How we are funded

Severn Hospice is part of the health services offered to people living in Shropshire, Telford and Wrekin and Mid Wales, but we are not part of the NHS. We are a completely independent charity and have to raise over two-thirds of our running costs.

Our care and emotional support is totally free for both patients and their families; but not without cost.

Our services are funded through a combination of kind donations from local people, fundraising activities, our lottery and retail departments, gifts in people's wills and grants from the NHS. For every £1 invested through NHS grants, we provide £3 worth of service to local people.

Introduction to Hospice at Home

The team consists of bank and contracted staff, with a mixture of Registered Nurses and Health Care Assistants. Care is normally provided in the last six weeks of life and regardless of diagnosis.

Referral Criteria

- Patients must be registered with a GP practice within Shropshire County or Telford & Wrekin CCGs.
- Patients can be referred regardless of diagnosis, but must be in the palliative or End Of Life phase of their illness.
- Patients should be in the last 6 weeks of life, and have palliative care needs (we are aware that this is difficult to assess).
- Patients must have expressed a wish to die at home.
- Family and carers must be in agreement and able to support this.
- An up to date care plan must be in place, and for the terminal phase, an end of life plan is required.
- The patient must be flagged to the out of hours medical service i.e. Shropdoc.
- The minimum request for care input should be 2 hours.



Procedure for Referral

- The Community Nurse will maintain overall management of the patient.
- Referrals may be made to the service by phoning the office on 01743 261506 between 9am and 10pm, including weekends and bank holidays.
- If a referral has been made for a patient who doesn't have Community Nurse involvement, an assessment may be carried out by service staff and then may be referred to the Community Nursing service, or referred directly to the Community Nurses for assessment.
- Hospice at Home is not an emergency service although every effort will be made to respond to an appropriate request at short notice.
- Patients referred should be on GSF, have a Just In Case box and End of Life Plan in operation where appropriate. Anticipated problems will have been discussed, with the GP and anticipated drugs should be prescribed and available prior to the Hospice at Home team visiting.
- Sufficient information about potential patients is crucial. The flow of information between teams, referring agencies etc should be ensured and detailed. Any potential hazards including patient behaviour, presence of dogs or other animals, or any hazard relating to a visit should be addressed at referral or when noted.
