- 2. Offer Complementary Therapies to patients within all areas of RSH and PRH that are supported by the Palliative End of Life Care team.
- 3. To attend daily team huddles and weekly multidisciplinary meetings with the Palliative End of Life Care team. To have a monthly 1 to 1 meeting with the Lead Complementary Therapist at the Severn hospice.
- 4. To represent the Hospice while working within SaTH and alongside the Palliative End of Life Care team.
- 5. Ensure accurate and timely notes are made in line with set standards following each treatment.
- 6. Work alongside the Palliative End of life care team to prioritise patients and workload.
- 7. Demonstrate sensitivity in dealing with complex and confidential information from patients, families and colleagues.

8. To work alongside PEoLC team admin staff to ensure a minimum data set is captured that reflects the numbers of treatments and quality outcomes.
